Applicants are responsible for presenting their projects at the public hearing. CAMPAIGN CONTRIBUTIONS. If you intend to speak on any hearing item, please indicate on your speaker slip and/or in your testimony, if you have made campaign contributions of more than \$250 to any Commissioner within the last year, and if so, to which Commissioners you contributed.
